

SMARTCOAT™ 201 TPO PRIMER FOR ACRYLIC

Product Information

Description & Use: SMARTCOAT™ 201 TPO Primer for Acrylic is a water-based, clear, acrylic primer. This product is formulated with a unique, premium acrylic resin that is designed to enhance the adhesion of acrylic coatings to aged TPO single ply membranes. SmartCoat 201 eliminates the need of a special base coat that is required when applying acrylic coatings to TPO membranes. Not for use over EPDM, PVC or other single-ply membranes.

Coverage: 0.5 gallon (1/2)/100 square feet.

Product Application



Use only in well ventilated areas. Avoid contact with eyes and skin. Use personal protective equipment as required.

1. Clean roof surface thoroughly with SMARTCOAT ROOF WASH. Surface must be free of dirt, dust, oil, grease, wax, rust, chalky or loose paint, mildew and any other surface contamination that may inhibit adhesion.
2. Allow surface to completely dry before applying PRIMER.
3. Rinse tools and equipment with water before using. Mix thoroughly before using. Do not dilute. Using roller, brush or spray equipment, apply to the properly prepared surface at the rate of 0.5 gallon (1/2) per 100 sq. ft. Do not apply PRIMER when surface or air temperature is below 50°F, or if cold weather, rain or fog is expected within forty-eight (48) hours of application.
4. Allow PRIMER to completely dry, typically 4-6 hours @70°F, before the application of SMARTCOAT ACRYLIC COATING; PRIMER will be completely clear and no longer milky white. PRIMER cures through dehydration. Drying time may vary depending upon wet film thickness, temperature, humidity and air movement. SMARTCOAT ACRYLIC COATING shall be applied as quickly as possible once the PRIMER is dry to avoid build-up of dirt/debris and compromised adhesion.
5. Clean wet coating with soap and water. Dry coating may be removed with mineral spirits. Use care when handling solvents.

The user of this material has the responsibility to dispose of unused material, residues and containers in compliance with all relevant local, state and federal laws and regulations regarding treatment, storage and disposal for hazardous and nonhazardous wastes.

Storage: Keep from freezing. Avoid storage near extreme heat, ignition sources or open flame. Store in cool, dry conditions.

First Aid
